Section 01: Instructions to Prospective Bidders/Economic Operators

In submitting their offers, economic operators must respect all instructions, forms, Terms of reference, contract provisions and specifications contained in this Expression of Interest. Failure to submit a bid containing all the required information and documentation within the deadline specified may lead to the rejection of the offer.

1. General Instructions

- 1.1. In submitting an offer, the bidder accepts in full and in its entirety, the content of this Expression of Interest, including subsequent Clarifications issued by the Local Government Division, hereafter referred to as Contracting Authority (CA), whatever the economic operator's own corresponding conditions may be, which through the submission of the offer is waived. Economic Operators are expected to examine carefully and comply with all instructions, forms, contract provisions and specifications contained in this Expression of Interest documentation.

No account can be taken of any reservation in the Expression of Interest in respect of the contents therein; any disagreement, contradiction, alteration or deviation shall lead to the offer not being considered any further.

Prospective bidders (economic operators - i.e. individuals and, or companies/firms) must submit their response to this Expression of Interest by completing the necessary documentation and by submitting such documents by e-mail and by the deadline as detailed in this document.

Note:

Where in this EOI document a standard is quoted, it is to be understood that the Contracting Authority will accept equivalent standards. However, it will be the responsibility of the respective bidders to prove that the standards they quoted are equivalent to the standards requested by the Contracting Authority.

- 1.2. The subject of this EOI is **“Provision of Free Wi-Fi Equipment including Configuration and Installation Requirements through the WiFi4EU Scheme”**
- 1.3. The Contracting Authority (CA) for this EOI is Local Government Division on behalf of Local Councils.

3. Lots

3.1. This Expression of Interest is not divided into lots.

4. Workshop/Clarification Meeting

4.1. No clarification meeting (physical/face-to-face) will be held. All clarifications will be addressed as detailed in Article 5.

5. Clarifications

5.1. Economic Operators intending to submit a proposal are to send their particulars on the e-mail: wifi4eu.localgov@gov.mt by the 15th June 2021, in case any clarifications need to be communicated to all interested bidders.

6. Financing

6.1. This Expression of Interest is financed through the Wifi4EU scheme on Europa official website <https://wifi4eu.ec.europa.eu/#/home>

7. Pricing

7.1. Pricing detailed in the EOI is in Euro (€) and exclusive of VAT.

8. Submission of Offers

9. Selected Conditions

9.1. The Local Government Division reserves the right not to select any proposal or to select multiple proposals as necessary to fulfil the needs outlined in this EOI document.

9.2. The Local Government Division reserves the right to award a Contract for Service to multiple Economic Operators (individual/s or firms) at the terms and conditions as outlined in this EOI document and attached Contract for Service. The decision of the Local Government Division in this regard is final and binding.

9.3. The selection process will be limited to the individual/individuals or organisations that submitted their intent to provide this service by the closing date of this call and are eligible according to the requirements detailed in this EOI. Individuals presenting their details for consideration outside the closing date of this call will not be considered.

9.4. The Local Government Division reserves the right to enrol any number of economic operators as required. The selection will be on the basis as detailed in the Evaluation Process based on Eligibility Criteria, Past Experience, Credentials and Suitability. However, mere satisfying these requirements will not entitle an applicant to be enrolled. The decision of the Local Government Division in all matters will be final and binding on the bidders.

10. Eligibility Requirements

10.1. In order to be considered eligible for the award of the contract, economic operator must provide evidence that they meet or exceed certain minimum criteria described hereunder:

a) Eligibility Criteria

Economic Operators are to complete the Eligibility and Technical Offer Form ^(Note 3) as available in Section 05.

b) Exclusion (including Blacklisting) and Selection Criteria

Economic Operators are to complete the information provided on the Exclusion Grounds Form ^(Note 3) as available in Section 05.

c) Technical and Professional Ability

It is the Economic Operator's responsibility to ensure that the correct information is reflected in the Forms included in Section 05 for the above criteria.

d) Specifications

Economic Operators are to fill and submit the Eligibility and Technical Offer Form ^(Note 3) as attached in Section 05 in response to specifications requested as part of this EOI.

Notes to Clause 10:

Note 2. *Economic Operators will be requested to either clarify/rectify any incorrect and/or incomplete documentation, and/or submit any missing documents within five (5) working days from notification.*

Note 3. *No rectification shall be allowed. Only clarifications on the submitted information may be requested.*

Requests for Clarifications and/or Rectifications concerning a previous request dealing with the same shortcoming shall not be entertained.

Section 02: Background

The Local Government Division on behalf of the Ministry for the National Heritage, the Arts & Local Government is looking to offer Public Wi-Fi throughout Malta and Gozo as per WiFi4EU standards <https://wifi4eu.ec.europa.eu/#/home> and <https://ec.europa.eu/digital-single-market/en/wifi4eu-questions-and-answers#TechnicalQuestions>

The WiFi4EU initiative promotes free access to Wi-Fi connectivity for citizens in public spaces including parks, squares, public buildings, libraries, health centres and museums in municipalities throughout Europe.

The WiFi4EU initiative provides municipalities with the opportunity to apply for vouchers to the value EUR 15,000. The vouchers are to be used to install Wi-Fi equipment in public spaces that are not already equipped with a free Wi-Fi hotspot.

The selected Economic Operator/s shall, whenever required by the Local Government Division or the IMU section of the Ministry for the National Heritage, the Arts & Local Government to attend for meetings held in Malta and in Gozo.

The selected Economic Operator/s will be required to install all needed access points per Local Council, offering 24/7 Monitoring and Reporting.

The selected Economic Operator/s will be required to confirm that all AP's are functionable and perform needed speed tests and configurations. SSIDs must meet the requirements as per <https://ec.europa.eu/digital-single-market/en/wifi4eu-questions-and-answers#TechnicalQuestions> - 9.3.

Section 03: Financial and Engagement Conditions

Interested Economic Operators that can fulfil the technical requirements and responsibilities as listed in this EOI, may be selected as a Wi-Fi installation company to provide and install Wi-Fi Access Points requirements throughout a number of Localities in accordance with the Wi-Fi4EU initiative.

In consultation with the Contracting Authority, each Local Council will need to declare a selected Wi-Fi installation company through the Wi-Fi4EU portal. The Wi-Fi installation companies will need to register its details and bank account credentials through the Wifi4EU Portal. Upon confirmation of successful implementation as per the obligations, the Wi-Fi installation company will receive the Eur 15,000 voucher directly from the European Commission to their specified bank account. i.e. The Wi-Fi installation company will need to provide and install all equipment and prove that it is operational. Once this is confirmed the voucher may be claimed. The financing for the requirements will be paid post implementation through the WIFI4EU Scheme directly by the European Commission up to a maximum of EUR 15,000 per Locality. The high-level process of the financial model will be as follows:

1. A wi-fi installation company is tasked through this EOI to provide and install the Wifi4EU free public Wi-Fi in selected localities.
2. The Wi-Fi installation company will need to register on the Wifi4EU Portal - <https://wifi4eu.ec.europa.eu/#/supplier-landing>
3. Each Local Council will go through the Wifi4EU portal and select the Wi-Fi installation company.
4. The Wi-Fi installation company will provide and install the free public Wi-fi access points in accordance with all obligations and requirements.
5. The Wi-Fi installation company will provide all details of the installed equipment as these are required as proof of the installation.
6. Proof that at least 10 users have connected with the individual access points will be carried out through the snippet installation requirement and reports.
7. Once all the above are confirmed and it is verified and authorised by the respective Local Council, the Wi-Fi installation company will receive the maximum of €15,000 through the Commission directly in their bank account.

Any operation requirements and related costs will be handled directly between the Economic Operators and the respective Local Councils and/or the Contracting Authority.

In case the installations do not fulfil the full obligations of the Wifi4EU scheme (which must be kept operational for a minimum of three (3) years) through audits, as per “ARTICLE 12 - EFFECTS OF TERMINATION”. Where the Agreement is terminated following the provisions of Article II.16.1 or II.16.3.1, the Agency may reduce the amount of the grant and recover amounts unduly paid in accordance with Articles II.25.4 and II.26. After termination, the concerned beneficiary’s obligations continue to apply, in particular those under Articles 4, II.5, II.7, II.8, II.13, II.27 and any additional provisions on the use of the results, as set out in Article 8, as per the sample main agreement.

If the Economic Operator’s contract is terminated and any tasks were assigned, they will be transferred to another Economic Operator. It will be therefore the current Economic’s Operator responsibility to provide a clear handover and cannot leave any Local Council mid-way of the project. Failure to provide full documentation and handing over, may result in a penalty of 25% of the total payments occurred. Any accesses to systems and portals are to be provided to the Local Council’s or its representatives accordingly and all services must still remain functional 24/7.

The Local Government Division reserves the right to terminate the contract at any time and shall in so doing, not be necessarily obliged to provide a reason for the termination.

The selected Economic Operator/s must declare any subcontractors involved and the direct contact points for such a project.

Section 04: Eligibility Requirements and Responsibilities

Applicants are to ensure that they possess the necessary experience and skills as requested in order to meet all requirements and obligations emanating from the WiFi4EU initiative. Applicants are therefore to take the full responsibility about the provision and implementation requirements of any equipment required, including configurations and operations.

A number of Local Councils were awarded a voucher of €15,000 each through the Wi-Fi4EU scheme. This expression of interest is seeking Wi-Fi installation companies (as defined through the Wi-Fi4EU) - to provide and install a number of Wi-Fi Access Points per locality to provide free Wi-Fi to the general public.

The minimum technical specifications of the equipment are detailed in section 6.2.2 of the call text, as well as Article I.2 of Annex I of the Grant Agreement signed between the municipalities and the Commission.

The municipality shall ensure that each Access Point:

- Supports concurrent dual-band (2,4Ghz - 5Ghz) use
- Has a support cycle superior to 5 years
- Has a mean time between failure (MTBF) of at least 5 years
- Has a dedicated and centralised single point of management for all APs of each WiFi4EU network
- Supports IEEE 802.1x
- Complies with IEEE 802.11ac Wave I
- Supports IEEE 802.11r
- Supports IEEE 802.11k
- Supports IEEE 802.11v
- Is able to handle at least 50 concurrent users without performance degradation
- Has at least 2x2 multiple-input-multiple-output (MIMO)
- Complies with Hotspot 2.0 (Pass point Wi-Fi Alliance certification program).

The minimum number of Wi-Fi Access Points that need to be installed either indoor or outdoor per Locality through the €15,000 vouchers (as indicated in section 6.2.2 of the call text and Annex 1/Article I.2 of the Grant Agreement) is as follows:

To provide an example, for each Locality, selected bidders will need to provide and install either 10 outdoor access points OR 15 indoor access points OR a mix such as 2 Outdoor and 12 Indoor.

The locations where access points will be installed (considering practicalities) will be decided by the Contracting Authority and the respective Local Council. Bidders who provide proposals that will maximise the benefits of the installations and ensuring the minimum recurrent costs (such as number of internet connections, electricity and maintenance) will be given preference. The main requirement is the number of access points in line with all obligations fulfilled. The voucher will also cover any networking equipment required (switch, repeaters, antennas, cabling etc).

Only one SSID (Service Set Identifier), with a captive portal may be broadcasted through the Access Points (Refer to Appendix 1 of the sample grant agreement), in addition internal only SSID's may be used strictly as directed by the Contracting Authority. Please refer to 9.3 and 9.4 of the technical FAQs:

“9.3. SSID (Service Set Identifier)

9.3.1. How should the network (SSID) be set up?

The WiFi4EU network SSID should be named according to Annex I of the Grant Agreement. The WiFi4EU network name refers to a name the municipality may want to give to the WiFi4EU network (e.g. City Hall) to identify it when communicating with HaDEA and to differentiate it from other networks.

9.3.2. Can we use an SSID other than WiFi4EU?

In addition to the standard "WiFi4EU" SSID (based on an open network and captive portal), it is possible to also broadcast:

- one SSID for internal use of the municipality, e.g. serving the staff of the administration services in the town hall or in the public library, or for a smart city project and/or
- one SSID to provide a secure authentication service of WiFi4EU users in the first phase of the WiFi4EU implementation (e.g. "WiFi4EU - Secure").

Note, that a secured Single Authentication Service serving all WiFi4EU networks in Europe will be established in Phase II of the WiFi4EU implementation (see also Q9.4). Therefore, if a local SSID providing secure authentication service is established in the first phase (as in the case above), it can either be removed during Phase II or it can continue to be broadcasted in parallel.

In any case, none of the additional SSID broadcasting should affect the quality of service offered to the general public. The municipality should also appropriately differentiate such SSIDs name from the "WiFi4EU" open SSID.

9.4. Who is responsible for the user authentication?

In Phase I of the initiative, the authentication, authorisation and accounting of users is the responsibility of the municipalities. In Phase II, there will be a single authentication system available at EU level, to which municipalities will have to reconfigure their networks to connect to it. The authorisation and accounting of users will continue to be a responsibility of the municipalities. For more details on these two phases, please refer to Annex I of the Grant Agreement.”

The voucher is only meant to cover the actual equipment and installation up to operational requirements as specified by the Wifi-4EU grant agreement. Bidders are expected to provide proposals as they deem best to achieve value for money. If any proposals are financially sound and exceed minimally the funds, these might also be considered. Leasing options with an option to purchase may also be considered.

The Wi-Fi access points must be “Wi-Fi CERTIFIED Passpoint® devices”. Make reference to 9.2.1

Each Local Council will need to declare the selected Wi-Fi installation company through the Wi-Fi4EU portal. The Wi-Fi installation companies will need to register its details and bank account credentials through the Wi-Fi4EU Portal. Upon confirmation of successful implementation as per the obligations, the Wi-Fi installation company will receive the €15,000 voucher directly from the European Commission to their specified bank account. i.e. The Wi-Fi installation company will need to provide and install all equipment and prove that it is operational. Once this is confirmed the voucher may be claimed.

Prospective bidders must also take note of the snippet installation required, as part of the Phase 1 obligations. The scope of the snippet is to keep track of the number of users connecting to each Access Point.

Appendix - Reference to local councils list

Post Installation, Recurrent Costs and Maintenance and Support

Recurrent Costs and Maintenance and Support are not covered by the voucher. These will be handled directly with the Contracting Authority and Local Councils post installation.

Bidders are expected to provide clear charges that could be applicable for Maintenance and Support requirements such as rate per hour for incident resolutions.

Preference will be given to bidders who guarantee minimum recurrent costs requirements.

The bidder can also offer a full package inclusive with connectivity via an Internet Service provider, however the bidder will be the main contact point for the overall service.

On the other hand, the Contracting Authority has the right to opt to pay directly the Internet connection (example: Existing internet connection that may be used for the purpose) in coordination with the supplier. Any such matters will be discussed with the selected bidder.

The bidder is expected to provide internet filtering mechanisms that will be adopted to filter inappropriate content through the SSID broadcasted through the Wifi Access Points.

Evaluation Process

1. The Evaluation Process will be carried out by an Adjudication Board appointed by the Local Government Division.
2. The Adjudication Board will score the offers individually, based on the following award criteria and the associated weighting as detailed in the evaluation grid as per below. The award criteria will be examined in accordance with the requirements as indicated in the Technical Requirements (Section 04) and the Eligibility and Technical Offer Form (Section 05 - Appendix III).
3. The Adjudication Board reserves the right to request the Economic Operator to conduct a presentation to further sustain their response to this offer.
4. Economic Operators must achieve an average technical score of (60%). The average technical score is arrived at by adding the individual weighted scores of each evaluator divided by the number of evaluators. Those individuals that do not obtain the minimum set average technical score will be eliminated.
- 5 The Contracting Authority reserves the right to task more than one economic operator, according to exigencies, provided that the minimum technical score is fulfilled.
