Local Council Meeting

28.10.15

Activities / Meetings

04/10 – Talent Contest

The Talent Contest was held in the Community Hall. There were about 10 participants and I must admit that I was truly impressed with the level of talent expressed by all those who participated.

A word of thanks goes to the organiser, Mr Paul Fenech and to the panel of 5 judges.

I sincerely hope that this will become an annual event.

06/10 – Halloween

A meeting was held with inspector Trevor Micallef and his assistants re security measures and patrols that should be applied during Halloween.

Also in attendance was Mr J P Barthet who on an annual basis organises a popular Halloween activity in his premises in Swieqi Road. An on site meeting was held. So as to decrease the confusion that may be caused, the possibility of turning part of Swieqi rd one way from 5 to 9pm from triq Ilqugh and triq Ilma was discussed. Vehicles entering Swieqi via Marbat and the tunnels would proceed in the normal way. Vehicles that need to exit Swieqi would need to do so either via Sirk/Migbed or Ilma/Ilqugh.

Mr J P Barthet was advised to have at least two wardens on site so as to direct traffic.

07/10 – Organic Waste

Together with councillor Mr Alex Chetcuti, I attended a meeting with Wasteserv officials and Mr Michael Cohen. During this meeting Wasteserv informed us that in the near future all households in Malta will be obliged to separate Organic waste from ordinary waste. On 30TH October 5 local councils will be participating in the first phase of its implementation and Wasteserv asked us whether we would be prepared to participate in the second phase of its implementation. This should be taking place during the end of January 2016.

We were informed that Wasteserv officials will be educating residents about the system and that they will also be giving out free white bags and a bin. The collection of organic waste will initially be held on Mondays and Fridays with the possibility that in the near future Wednesday will be included. We were informed that on the day that the white bag will be collected, the black bag will NOT be collected.

From an exchange of e mails between councillors it has been noted that some councillors are not at all happy about the fact that the black bag will not be collected on the day that the white bag will be collected, and that is on Mondays and Fridays.

I am of the opinion that our council should participate so as to adopt the new scheme. We clear any doubts that we may have with Wasteserv and we should also monitor how the system will be working in the other 5 localities.

07/10 – Art Council

I had a meeting with the board of the Art Council. I explained the importance of Culture and the necessity that people are exposed to it and be encouraged to participate, particularly children.

I also explained why it was important to set up a Regional Art & Culture Centre, particularly in Swieqi, where all forms of art will be thought and exhibited and I emphasised that it would be interesting to link the launch of the Art and Culture Centre to V2018, the year when Valletta will be the European Capital City of Culture .

11/10 – meeting with Mr Jason Micallef, Chairman of V2018 and CEO Dr Kersten Xuereb

Councillor Mr Paul Fenech, Gzira mayor Mr Borg Manche and myself met Mr Jason Micallef, Chairman of V2018 and CEO Dr Kersten Xuereb, so as to discuss the possibility that Swieqi, St Julians, Pembroke, Sliema, Gzira and Ta Xbiex Local Councils obtain funds so as to organise cultural activities in conjunction with V2018.

Both Mr Micallef and Dr Xuereb were very supportive. Mr Micallef informed us that even though Swieqi and Pembroke were not in the same region as the other local councils, he would be doing his utmost so that this anomaly will be overcome. It is planned that meetings will be held with organisers of cultural activities.

This is an initiative of Councillor Paul Fenech who is spearheading this group of local councils and he will be keeping us informed of proceedings.

16/10 – Traffic Management

I discussed the possibility of introducing new traffic management in the vicinity of Triq Stasija with Transport Malta official, Mr Charles Muscat.

About 20 new parking bays have been introduced in triq Stasija and Lebrun. However, in order to increase road safety it is necessary to introduce some new one ways.

It is being proposed that triq Stasija from Ibrag to Lebrun becomes one way down. This will enable us to introduce parking bays on both sides of the road. Part of triq Lebrun (from Stasija to Franciz) will be turned to one way towards Franciz. This way we will be able to have parking bays on both sides of the road and we will also avoid the dangers of a cross road. Triq Famucelli will become one way in, from Franciz to Stasija. Once Triq Stasija will become fully accessible, Triq Lebrun from Kartocc to Stasija will be turned into a one way too.

Triq in Nofs, which is a very narrow road, will become one way up.

Mr Muscat is in agreement with the changes. We need to present our formal request and once our proposal will be accepted we will discuss the changes with the residents.

Triq il Giebja / Triq L-Ilma / Triq il Hawt

This is a very dangerous cross road and we need to identify ways how we could make this cross road safer, especially now that the road is expected to become busier due to the increase in residents that are expected to reside in this area due to the substantial amount of property development that is taking place in this section of the locality.

21/10 – Disability Sub Committee

The Sub Committee for people with a disability was launched. Mr Charles Palmier and Ms Bridget Micallef were in attendance. Ms Roberta Magri was excused since she was unwell. Mr Mark Stephenson is helping in the setting up of this Sub Committee and for this I'd like to thank him.

The Sub Committee has to inform Council about what is required to make the locality more accessible for people with a disability.

The Local Council, on the other hand, has to make it a point to integrate people with a disability and to always encourage them to participate in all the activities that are organised by the Local Council.

I propose that the sub committee will be offered space in the council's magazine.

27/10 – Council’s Management Accounts to 30th September, 2015

The Council’s accountants presented the management accounts to 30th September, 2015. The accounts show a slight deficit, however this was due to resurfacing works carried out in triq Marbat.

Day Centre – Active Ageing Hub

I have been informed by the Department of Active Ageing that they may be prepared to start organising activities without carrying out any structural alterations in the Church Hall.

In an effort to cut down on costs they are prepared to offer the tutors/lecturers but wish that the participants will be self sufficient, in the sense that participants will help with certain organisational duties. I was presented with a list of activities that are organised in other active ageing centres around Malta and are waiting for our reply whether we would like to go ahead.

Meeting with the Hon Joe Mizzi

On Thursday 29th October at 12.30 we shall be meeting the Hon Joe Mizzi, Minister for Transport. Together with various other Transport Malta officials we shall be discussing the expected increase in the volume of traffic in Swieqi via the valley from linking Swieqi with San Gwann once road works in the regional road/Kappara intersection get under way.

- A) **Safety.** Once the road in the valley is widened and aligned, safety measures will need to be introduced so as to decrease speed due to the steepness of the road and the ninety degrees bend.
- B) **Pavement** – we need to insist on the installation of a pavement
- C) **Triq tal Franciz** – the increase in the flow of traffic will increase the flow of cars that will be passing through triq il Keffa, which already experiences an overload of traffic and is in a pitiful state. For this reason we need to insist that triq tal Franciz will be made fully accessible so that any traffic heading towards the Ibrag/ Madliena/Victoria Gardens area need not drive through triq il Keffa
- D) **Triq it Terz/triq F Assenza** – as above
- E) **Triq Gizimin/triq il – Qasam** – as above
- F) **Triq ir Ratal/triq L-Ibrag** – as above

Advertising Space

We are exploring the possibility of embellishing triq I-Gharbiel, particularly the stretch that has metal bars that act as a safety measure. We plan to instal planters along this stretch and we have asked ELC to provide us with a quotation.

In order to finance the installation and maintenance cost we plan to instal advertising boards that will be visible only from St Andrews road.

Subject: MINUTES COUNCIL MEETING NO.10 – 28TH OCTOBER'15

Hugh, herewith brief summary of those points which raised during the above meeting for attachment as an appendix to the corresponding minutes:

01. *Kuntratti Tal-Kunsilli Lokali* – several had long expired and when asked, Deputy Mayor confirmed that most were in the process of being finalised for submission to the authorities during week commencing 2nd November.
02. Pavement bins – the possibility of acquisition of better and more suitable pavement bins ideally partly funded through the MTA was explored and Exec. Secretary would follow up and if in the negative appropriate quotations obtained from three different sources. These should be along the lines of those installed by nearby local councils.
03. Triq il-Qasam – The problem over lack of vision to vehicles transiting the corner of Triq Is-Sidra with Il-Qasam remains and a long term solution essential as the matter had dragged for much too long.
04. Triq is-Swieqi (F.X. Ebejer Garden) – WIFI facilities in the area had still not been installed and Exec. Secretary undertook to contact the person responsible and whom he had met on site in May for purposes of actioning the matter.
04. Swieqi Entrance Upgrade – The Mayor confirmed that original efforts to obtain a sponsor remained inclusive but he would pursue accordingly.
05. Directional Maps – No further contact had been made with the contractors and at the request of the Mayor, I should call Joe Fenech Soler of Blue Limited to update certain amendments to the draft received some time ago thereby accelerating completion.
06. Council Magazine Christmas Issue – this was in the pipeline and as previously he would jointly compile with the Deputy Mayor; deadline for submission of individual contributions set for 15th November.
07. Arms Limited – Arising from the Finance Sub-Committee meeting held in September, it was imperative that an official amended invoice made out in the name of the Swieqi Local Council be received in replacement of the original document invoiced to the Ministry for Transport & Infrastructure. For obvious reasons, as indeed confirmed by

Herewith comments and clarifications where required:

- 12/31. Mica Med various – settlement of amount due withheld pending compliance with contractual conditions (omission of repair dates).
