

#### 27/07 – Meeting with Perit Christopher Borg – Director Planning Authority

Together with Councillor T Valentino and Periti Rossignaud and Vaalentino we met PA Director Perit Borg and another official from PA.


We discussed the minutes of the previous meeting as well as other issues, such as parking, overdevelopment, open spaces, front gardens etc. Councillor Valentino will report about this meeting

#### 27/07 – Meeting with Perit Stephen Mallia – head of Wardens North region

I discussed the garbage problem with Mr Mallia and asked him to enforce the law. Together we walked to triq i-Imghazel and triq il Qasam and since it was Wednesday he witnessed with his own eyes several garbage bags that were lying on the pavement. He said that he would be making contact with the owners of the flats. All I can report is that garbage is still being taken out on the wrong day, and that includes today as per attached photos.

#### 4/08 – meeting with Mr Herman Galea – head of Parks

met Mr Herman Galea and his assistants so as to see what kind of help would be given to the Council by his department. It was agreed that 3 workmen could be allocated to carry out works whereas the local council would pay for the materials.

was also informed that several trees called Brazilian Pepper (about 20 of them) would have to be removed since they are not good for the dogs.

The project is at a standstill because we do not have the required PA permits.

#### 8/08 – Meeting with Mr Michael Cohen – official at Transport Malta


Mr Michael Cohen has been appointed as an official at Transport Malta. I met him so as to renew my plea for assistance that our council needs from the department with regards to resurfacing of roads and making dead end roads fully accessible.

also presented to him the report that the council had presented to the Hon Minister Joe Mizzi when he visited the council on 10.04.13 as well as the report of the Council's meeting with The Hon Joe Mizzi on 29.10.15. He promised to involve himself and see how he can help us.

Incidentally, on 18.08.16 I sent an e mail to the Hon Joe Mizzi asking him once again to allocate funds for the resurfacing of Triq il Keffa and his immediate reply was that the matter 'is being given its due attention'.

#### 11/08 – Meeting with Mr Kenneth Demartino

discussed the possibility of building an underground car park in Grien F X



## **Berga**

I am pleased to inform Council that the services of the Berga will be extended to twice weekly. Another session will be held every Friday starting for Friday 2<sup>nd</sup> September.

I have asked the Department so that the Berga will be transferred with immediate effect to the Civic Centre. They are considering doing so.

The Health Department is going to pay for the installation of a flexible partition in the Community Rooms, as well as for the basic furniture required.

This augurs well for the increase in medical services that may be provided to our residents.

I would like to take the opportunity to thank Dr West and his team from the Health Department for the assistance given.

## **Disappointment / Let Down**

I would like to express my great disappointment about the way that the council has been let down by its Architect and Executive Secretary vis a vis the Embellishment of Gnien F X Ebejer and the Dog Park.

## **Gnien F X Ebejer**

With regards to Gnien F X Ebejer, although the tender was awarded about three months ago, the project has not yet started because we are still waiting for PA to give us the green light since they maintain that our architect has not been given all the details required. Unfortunately nobody pushed the architect or PA to hasten up matters. A total let down and a great disappointment.



## Dog Park

As we all know, after discussions with the Parliamentary Secretary for animal welfare and officials from his office, it was decided to extend the foot print of the dog park since the space allocated to the dog park as per original plans was deemed too small.

The plans were duly adjusted by our architect, but surprise surprise, nobody took the initiative to apply to PA for the necessary permit. So here we are stuck once again. I consider this as a total let down from officials who should know better what needs to be done without having to be pushed and pushed and pushed.


## Garbage

In my opinion the waste separation is working very well and I would like to thank the vast majority of the residents for their efforts to keep up with the garbage collection schedule.

However we are facing problems in certain roads, mainly in roads where there are short let flats. I regularly report the matter to LESA, Malta Tourism Authority and Wasteserv and I beg them to intervene and enforce the law. Unfortunately to date we have not received the required assistance.

I am convinced that if the authorities enforce, the situation will improve drastically not only in Swieqi, but in the whole of Malta. Moreover it is very important to take action immediately, before the number of short let units increase.

In my endeavour to solve the garbage problem I am trying to find out who the administrators of certain blocks of flats are. A few weeks ago I asked the Executive Secretary to find out who the administrator of CAROB flats in Triq il Iebja is. Unfortunately to date I have not been informed. These flats regularly take out a substantial amount of garbage on the wrong day and at the wrong time. Naturally there are other flats that regularly cause such problems, such as five blocks in Triq l-Imghazel, 'Dusk Court' in Triq il Qasam, Ivy Mansions in Triq il-Imghazel besides others of course



### **List of Licenced Apartments**

With the help of Mark Stephenson, we managed to obtain a list of apartments/residences that are duly licenced to be let out on a short let basis. I sincerely hope that the Executive Secretary will make good use of this information.

### **New Junction St. Andrews Road/Triq il Qasam**


I have been receiving complaints from residents who live in the area and make use of garages that are situated where Jolly Jumpers is located, since they now have to take a long detour if they need to head towards St Julians. I have asked for the assistance of Transport Malta so as to see whether a solution can be found

### **Development**

We all know that a great amount of development is taking place in the locality and considering the numerous applications that we are receiving on a daily basis, one can easily conclude that this situation is going to remain with us for a very long time.

The local council is not equipped to vet the applications professionally or even to monitor proceedings/development.

Periti Edgar Rossignaud and Anton Valentino are offering the council a sterling voluntary service and for this we heartily thank them. However this cannot go on for long. We must find a solution to this problem and I suggest that during our next council meeting we try to find a solution to this problem.



## Blocked Pavement – Swieqi Road

We had asked PA to inform the local council when a development was about to kick off so that the local council will be in a position to be proactive and take the steps that may be necessary to be taken, such as to build a temporary pavement, organise traffic management measures etc. we had also asked PA to allocate an individual who will be in charge of development in Swieqi, so that we will have easy and quicker access. Although in principle PA officials agreed to this, to date nothing has happened.

In Swieqi Road, close to J V Pharmacy, the developer has removed the use of the pavement without offering an alternative pavement, with the consequence that people have to walk in that very dangerous section of the road. We have spoken to developer and asked him to build a temporary pavement, we have informed PA, we have painted a yellow line so as not to allow vehicles to park, but all this has been in vain. This is a case in point why the local council MUST be informed beforehand that a development is going to take place and the developer must make contact with the local council.

This case happened several weeks ago, and here we are at a total status quo. I am of the opinion that this is a total disservice to the community and I feel ashamed of being totally powerless to be able to help not only residents but even people visiting our locality.



Good morning,

Herewith those points I had planned to raise during the above meeting but due to time constraints it was agreed to discuss during the first meeting in September:

- a. Summer Magazine – as pointed out in my e-mail accompanying the Schedule of Payments for period ended 16<sup>th</sup> August, the problem experienced by Medgraf Ltd over shortage of advertising inserts should have been resolved by allowing the company involved an extra full page advert slot in the Christmas edition; rather than the council accepting to pay Euro 330.40 for the shortfall. This is being raised to ensure no such repetition in the future.
- b. Financial Statement – As agreed during the last Finance Committee Meeting, review of data for nine months ending 30th September should not be delayed beyond the third week of October thereby allowing sufficient time for any adjustments both in terms of the Budget Estimates, any appropriate expenditure controls for the rest of the year; this in particular, in anticipation of the impending handover to the Executive Secretary's successor.
- c. Executive Secretary's Successor – Once Selection Board established, various meetings planned for purposes of pursuing procedures as required by the authorities concerned.
- d. WIFI – FX Ebejer Public Garden – any developments re installation ?
- e. Electronic Signage – Had any action been taken to install electronic signage in response to Transport Malta's e-mail of the 10<sup>th</sup> July?.
- f. Residents had complained about the presence of chewing gum over some pavements particularly along Triq is-Sidra in the vicinity of the Garden View Complex.
- g. Christmas Street Lighting Tender should not be delayed allowing the successful contractor to apply for the relevant Enemalta permits.
- h. Location Maps installation delays?
- i. Summer magazine – to be put on council's website.
- j. Swieqi Main Entrance – when are repairs to the damaged ceiling expected as also installation of 'cats's eyes' along the pathway on the other side of the entrance?
- k. Culverts annual cleaning?
