

Swieqi Local Council Meeting

Meetings Held :

24/09 – UIF Funds

On the 24th September we had the honour to greet in our locality the Hon Deborah Schembri, parliamentary secretary for lands, The Chairman of PA, Mr Vince Cassar and the CEO of PA, Mr Johann Buttigieg. Also present were the vice mayor of Mellieha and the Mayor of Mqabba. The event took place in Gnien F X Ebejer.

Our council was presented with the UIF funds with which the tennis court was embellished and we also signed the contract for the provision of the UIF funds required for the embellishment of Gnien F X Ebejer.

In my address I welcomed the honourable guests to our locality and thanked them for organising the activity in Swieqi. I admitted that the PA officials and the Hon Schembri had a difficult job to handle and I asked them to think twice before they take decisions that may have a negative effect on the locality. I begged them to maintain a balance between the volume of development and open spaces available, the road network and accessibility in the locality.

26/09 – Chinese Ambassador

Attended an activity organised by the Chinese Embassy in honour of the new Chinese Ambassador to Malta. I welcomed the Ambassador, whose residence is in Victoria Gardens, and I asked him to kindly consider organising a cultural activity in our locality. To be followed up.

07/10 – Triq il Majjistral

Vice Mayor Dr Justin Fenech, Coucillor MaryAnne Abela and myself met with residents in triq il Majjistral so as to discuss state of the road and adjacent land.

The residents are very worried that the owners of the land which is being developed may have the intention of changing road alignments so that they will acquire more developable land. We have informed our architects to look into the matter and we shall be meeting on site so as to confirm whether things are being carried out according to local plans.

The residents are also very worried about the level of dust in the area. It appears that Transport Malta may be postponing the laying of tarmac in triq il Majjistral until the services in the newly developed area are laid. The residents are of the opinion that the two projects need not effect each other and they insist that triq il Majjistral should be completed without further delay. We shall be confirming this with our architect and will be writing to Transport Malta accordingly.

08/10 – Embellishment in Triq Uqija - Pjazza

I met shopkeepers in triq Uqija so as to discuss the plans re embellishment of Pjazza Uqija. They are in agreement with the plans that we presented and they are of the opinion that January may be the best time to carry out the works. This, however, will depend on how long the works are planned to take. I was in contact with Mr Joseph Portelli, the developer of the Forum, so as to obtain confirmation re time frames. He has to consult his architect.

An issue that has to be solved is with regards to the total cost of the project and the amount that will be financed by the developer. We may have to finance a part of the cost.

Permits

It is very important that the architect applies for the necessary permits without any further delay and I am hereby asking the Executive Secretary to liaise with architect Dieter Falzon with immediate effect.

05/10 and 12/10 – Paceville Masterplan

I attended both sittings of the Parliamentary Group which is discussing the proposed Paceville Masterplan.

I fully agree that Paceville needs a drastic upgrading and I welcome the presentation of a masterplan to that effect.

It is a massive and very ambitious project. The residents are expected to increase from the present 2,000 to 10,000. The project is expected

to create 10,000 jobs and the facilities offered are expected to attract large crowds of people.

I informed the board that I am very worried about the negative effect that a project of this size may have on Swieqi. Swieqi already suffers a great deal with the present level of activity that takes place in Paceville. Just imagine what may happen with a project 10 times the size of the present one.

The project is too big to be fitted in a 'cul de sac', especially when one considers that the surrounding areas are already densely populated, thus St Julians, Sliema, Gzira, Msida, San Gwann and Swieqi. It is true that there are plans to improve the traffic flow in Paceville, even by building a tunnel. However, the exit of the tunnel will be onto the regional road. Can regional road cope with the expected increase in traffic that will be generated ? will this traffic spill into Swieqi ?

Also, since a third of the proposed buildings will be offered as office space, there exists the possibility that the demand for residential dwellings in Swieqi will increase, since a substantial amount of the people working there may seek residence in a nearby locality.

I asked the board to assure us that this massive project will not be effect Swieqi negatively.

10/10 – meeting with PA officials

Perit Borg and Perit Scalpello from the Planning authority made a presentation of the Paceville Masterplan to the Local Council.

Perit Anton Valentino was also in attendance.

Various questions were put forward to the PA officials. It is evident that since various studies have not yet been published, it is difficult for the experts to conclude on the sustainability and viability of the project. Thus it appears that reports on the traffic flow, the social impact, energy and drainage requirements etc have not been published yet.

I suggest that once these reports are published the Swieqi Local Council will present its own report on the project. I suggest that we appoint an architect to prepare the report and I am of the opinion that the local council organises a locality meeting on the subject matter. We have to be careful about timings since closing date for submissions is the 4th of November.

Road Works

Triq Giokondu

Triq Giokondu has been surfaced. The contractor caused residents and drivers a great deal of inconvenience since he closed the access

to the road on at least two occasions without obtaining the necessary permits and without offering an traffic management solutions, with the result that people had to drive one way down Uqija and exit into Ibrag road. Several drivers were served with fines. We informed LESA about this and they said that nothing can be done from their end and suggested that those who were fined should submit an appeal.

Herewith those points which I raised during the above meeting for attachment as an appendix to the corresponding minutes:

01. Financial Statement q/e 30th September'16 – to remind that updated document to be received from our accountants for review ahead of the council meeting of the 10th November
02. WIFI F.X. Ebejer Garden - Exec. Sec. would pursue installation of this facility which has been pending for well over a year.
03. Electronic Signage – Nothing done as yet in response to Transport Malta's e-mail of the 10th July. Matter to be further discussed during next meeting.
04. Council Magazine – Deputy Mayor to circulate all over deadlines for submission of individual's contribution. Ideally distribution tentatively planned by the 8th December.
05. Apart from ongoing attempts to secure sponsors to embellish the area, the damaged roof badly needed plastering with cement, an issue previously raised some months ago.
