



LOCAL COUNCIL MEETING

10.11.2016

MEETINGS HELD

19/09 – meeting with Green Pak

We were presented with various statistics which showed an increase in waste separation in the locality.

Discussed the present situation and we asked Greenpak to increase the collection of the grey bag to twice weekly and the collection of glass to twice monthly. Councillor Alex Chetcuti will report in detail.

19/09 – Meeting with HSBC Ibrag Manager Ms Lorraine Zammit

The manager showed interest to help the locality. that was very good news ! I asked her to purchase a toy for children which will be installed in one of our play grounds, either Gnien F X Ebejer or Gnien I-Imhallel Maurice Caruana Curran

26/10 – Berga Agreement

The agreement was signed with the Health department, whereby the services of the Berga will be transferred to the Civic Centre as from 15th November. The service will now be offered twice weekly, on Tuesdays and Fridays. They also confirmed that they will be paying for the flexible partition that is going to be installed in the Community Rooms.

28/10 – John Fenech – noise abatement NGO & Mr John Sacco - resident

We have been receiving several complaints from residents living in the vicinity of Wied Mejxu due to the noise being generated by machinery used by the contractor who is working on the Interconnector tunnel. These works have been going on for about three years and are excessively behind schedule.

It was agreed that Mr John Fenech would approach the employer, Enemalta, and ask them to replace the machinery with one that is more silent.

Meanwhile we have asked for a meeting with Enemalta officials so as to discuss the subject matter.

28/10 – St Julians Local Council Public Meeting re Paceville Masterplan

Attended the Public Consultation meeting organised by the St Julians Local Council.

02/11 – Parliamentary Group Meeting – Paceville Masterplan

Attended the third meeting organised by the Parliamentary Group re Paceville Masterplan.

The foreign authors of the plans, Mott MacDonald and ??? were in attendance.

I pointed out that with the present level of activity taking place in Paceville today a large part of the locality of Swieqi, which is a residential area, suffers great inconveniences, nuisance and damages. Now that the population living and attending Paceville is expected to increase five to tenfold, I asked them for assurances that Swieqi will not be negatively effected in any way.

I also asked whether and consideration had been given to the fact that Paceville will probably become the most densely populated locality in Malta and the surrounding areas are all very densely populated, thus St Julians, Sliema, Gzira, Msida, San Gwann and soon Swieqi too.

The population in Paceville is expected to increase from 2,000 to 10,000, it will offer 10,000 jobs, the bed nights are expected to increase. To all this we have to add the service providers and the numerous people that are expected to flock to the area so as to make use of the facilities and amenities.

I personally cannot fathom how this tremendous increase in population will not effect Swieqi in any way.

04/11 – Meeting at The Curia

A reconciliatory meeting was organised at the Curia by Mon Frans Abdilla and the Prish Priest Fr Mario Tong.

05/11 – Mayors' meeting

I attended the mayors' meeting held at the Verdala Palace. I was a guest speaker in a short discussion on E U Urban Agenda together with Pembroke's Mayor, Dr Dean Hili and Ms Hella Dunger-Loper from the EU. The discussion was chaired by Dr Aaron Micallef.

07/11 – PA Public Consultation re Paceville Masterplan

I attended the Public Meeting held by PA at the Hotel Meridien.

I once again asked for assurances that Swieqi will not be effected negatively and what measures have been taken for this to be avoided.

I also asked PA whether they have had discussions with Central govt so as to plan for the expected increase in the Maltese population.

There is no doubt that the 10,000 residents and 10,000 jobs in Paceville , plus the residents in the Sliema towers and those in the Mriehel towers and all the other towers that will be built will accommodate foreigners. To this we have to add the students attending 'foreign' university and the patients that are expected to come to Malta for treatment. Is the country prepared for this sudden increase in population and above all, do we want such an increase ?

Paceville Masterplan – Locality meeting

I have been in contact with Mr Peter Gingell from the PA authority and have been asking him so that PA officials attend a Public Consultation meeting with Swieqi residents. This way they will be able to reply to the residents' concerns and assure them re measures that will be undertaken to safeguard the locality. they will be able to explain the new road network and the way that the tunnels will

I immediately wrote to the Prime Minister about this, and I immediately received a reply from Mr James Piscopo, CEO at Transport Malta. The reply contained the usual brag that roads are the responsibility of the local council, that for the dead end roads to be made fully accessible there was certain criteria that had to be satisfied and he also gave me a list of works that were carried out by TM.

I replied to his e mail pointing out our lack of funds , that the dead end roads satisfy all the criteria for them to be made fully accessible and that the roads that were surfaced by TM were those that were surfaced for the first time and not repairs.

This situation cannot go on any more. It is simply not fair that our locality is always excluded and ignored.

It is worth noting that funds have been allocated to various other localities for embellishment, sports projects etc, and these include Fgura, B'Bugia, M'Xlokk, Zabbar, Imsida, Valletta, Paola and Zebbug besides others.

Financial Statement – 9 months ended 30th September' 16

Dear All,

Reference is made to the documents circulated during the local council meeting of the 13th October. Herewith my comments where considered appropriate which are restricted to the those Expenditure items showing significant variations compared to Budget'16:

Notes to the above:

- (1) The actual figure for the year is likely to be higher even allowing for reimbursement by Waste Serv for one of the weekly organic waste collections expected to total 18,000. In this regard, no payment has as yet been received for the months of February/September and pressure should be applied for early settlement.
- (2) This has reached excessive proportions and perhaps one should consider applying a nominal fee to counteract this overhead.
- (3) In the absence of any major bulb repairs etc., a positive variance is forecast. For the record, no provision or inclusion has been made for repairs undertaken in May on behalf of Transport Malta and involving 2,900 which are being reimbursed by the latter. Immediate action for recovery is recommended.
- (4) Unless inclement weather persists over the coming two months, the positive variance should materialise.
- (5) Mainly consequent to costs stemming from cutting of shrubs and weeds obstructing pavements. Although most are justified, those outside private residences should be borne by the respective property owners.

Naturally, any clarifications arising will be discussed in the course of today's council meeting,

Points to be made at Swieqi Local Council meeting on Thursday 10th November 2016

1. A Swieqi resident wishes to carry out a programme for autistic children and has requested a space at the Local Council premises to hold classes for this purpose there. I think the Council should encourage such initiatives and I am asking for the Council's approval.
2. I refer to case reference PA/03150/16, re proposed change in use from residential use to class 3a hostel in Triq is-Swieqi. I attended the hearing on behalf of the Swieqi Local Council and am glad report that the proposal was refused on the basis of our objections, being that this is a Residential Priority Area, and residents have a right to live in peace and quiet. It is worth noting that the Chairperson placed great emphasis on the fact that 1. the objector was the Local Council who is representative of the community of Swieqi, and 2. that the objector was actually present at the hearing, thus giving a lot more weight to the objection submitted.
3. Has our lawyer submitted his report re: rocks still in existence where there should be a pavement in Triq il-Qawsalla corner to Triq ix-Xeber? We need to move on with this and decide who is responsible for their removal and formation of the pavement.
