

Further to my today's earlier e-mail, herewith those points which need discussion and/or correction. As already intimated, settlement of the balances due to the undernoted should be withheld pending clarification, precisely: Mica Med, Arms Ltd and Dr. Fenech Adami.

- 03. Executive Secretary (79.57) – should read 79.52
- 05. Office Point (385.04) – should read 385.08
- Emoluments (7,658.53) – includes C. Gough's salary to be reimbursed to us (please follow up).
- 17. ECAD (300.00) – description to read : subscription 2017
- 20. Arms Ltd (3,373.59) – this seems high, pleased compare with previous bills received and whether part relates to the Police Station and Malta Post
- 21. Arms Ltd (87.23) – in spite of several earlier reminders, bills still incorrectly addressed.
- 23. Dr. Fenech Adami (300.00) – Did the previous fees note received cover six months ended 30th June?
- 28. Dieter Falzon (41.30) – no supporting invoice?
- 45. Corex Int. (26.24) – no supporting invoice?
- 62/92 Mica Med (various) – needs further discussion/clarification with you particularly insofar as those bills approved for payment by Engineer Galea Curmi. Suggest signed blank cheque issued for completion once position reconciled.

On a general note, please ensure that any bills received from both S. Sammut and S. Mifsud incorporate precise dates of when repairs have been undertaken. In the absence of such information, no payment should be effected before approval by the local council as has happened in the past.

Likewise, presumably due to the limited presence of the Executive Secretary over the past weeks, several invoices have not been rubber stamped nor signed by him. Please regularise.
