Hopefully, there will be a sufficient number of colleagues to make up a quorum for today's meeting, otherwise probably obliged to postpone to Monday in the evening when more convenient for most. This should still give you enough time to lodge the document with the department concerned by Tuesday's deadline of the 30th April.

In the meantime, I confirm having gone through the amended set of the above document and my principle remark concerns page 17 under Personal Emoluments - Social Security Contributions (item 6) and Operations & Maintenance Expenditure - Road Markings & Street Signs (item 7)

As will be recalled and as recorded in the minutes of meeting No. 13 held on the 20th February, the council had requested more details, in particular to Road Markings & Street Signs the amounts of which varied considerably when compared with the corresponding expenditure for Financial Year 2011.

As well over two months have elapsed and no information received to date, it probably is too late to insert an explanatory note on the same page to quantify these figures in line with usual practice. In the circumstances, I will approve the amended document on condition that the council's accountants provide the required clarification in time for our first council meeting on the 8th May, also requesting that this e-mail be attached as an appendix with the corresponding minutes.
