Dear Hugh,

As agreed with you and for the benefit of those colleagues who were obliged to leave early and/or unable to attend, herewith details in brief of various points /issues raised by me:

- 01. Annual Locality Meeting – As stipulated by regulations, minutes should have been circulated to all for discussion during the first council meeting following the 3rd April. Although at my request, a copy was e-mailed to me, the rest of the team had not as yet been provided with a copy. Therefore, this should be done in time for the 29th May.**
- 02. Triq is-Swieqi – Entrance Tunnel sponsored upgrading. (*Mayor confirmed that official permit approval still awaited*)**
- 03. Council Meetings Streaming online Developments. (*Executive Secretary confirmed that this would commence on installation of further technical requirements*)**
- 04. Police General HQ - E-mail d/7 April received from CID Dept re fixture of April/May meeting. (*Exec. Sec. telephoned Police Sgt Anthony Portelli for postponement*)**
- 05. Directional Maps – Installation at strategic locations similar to those placed by St. Julian's Local Council. (*Exec. Sec would obtain more information*)**
- 06. FX Ebejer Public Garden – Essential to surround Exercising Equipment area with low wooden fencing for purposes of restricting access to young children, as also dogs whose owners were irresponsibly allowing their pets to mess up the rubber mats.**
- 07. Gieh is-Swieqi Annual Award – It was agreed that this proposal be finalized during the meeting on the 29 May if this was to be introduced in time for this years' SwieqiFest.**
- 08. Street Sweeping/Weed Cutting Contract – When asked whether there had been any developments over extension of the existing contract, the Exec. Sec. confirmed that both he and Alex Chetcuti had met the contractor responsible and more discussions were imminent for purposes of regularizing the complaints raised by various residents and/or councillors. Whatever outcome subject to a trial period of one year commencing from the expiry date of the 5th May'14**
- 09. Triq is-Sidra – residents in the vicinity of the Garden View had complained over the bad state of the awning covering the reservoir belonging to the Garden View and sought the intervention of the council. (*The Exec. Sec. would intervene with the owners*)**
- 10. Financial Statement for Quarter one – When were we to expect this data? (*Exec. Sec. confirmed*)**

- 11. Triq il-Qasam – Zebra Crossing Lights outside The Corner Store – Although several reminders had been sent to Mica Med, the place remained in darkness. Also, when was the tree being planted in the same area together with the installation of other measures to facilitate the vision to oncoming vehicles from Triq is-Sidra.?**
- 12. Schedule of Payments – Although approved as recorded elsewhere in the minutes, the following clarifications from the Exec. Sec. were still awaited:**
 - a. Tipping Fees – How was the present system now operating as requested in my e-mail some months ago?*
 - b. Lifelong Learning Courses – Had reimbursement from the authorities concerned been received?*
 - c. Marindex Ltd. – Had the council committed itself to bear the cost of Euro 470.00 in respect of the marble plaque fixed at the Swieqi Police Station?*
 - d. Mica Med – Had the contractors been notified about our requirement for inclusion of the following dates on their invoices: Works Orders, Completion of Repairs & Actual invoice date?*
 - e. Koperativa Tabelli u Sinjali – Details of the missing information had now been obtained by the Exec. Sec and passed on to me for further scrutiny.*
