**Subject:** VARIOUS MATTERS FOR ACTIONING

Dear Hugh,

Herewith updated list of items for actioning at the earliest possible:

**01. Lighting -**

- a. Triq is-Swieqi - Yellow bulb on zebra crossing next to telephone booth opposite my residence. This was replaced some weeks ago and the contractor had guaranteed a longer life. On this basis, we should not be charged for the cost involved.
- b. Triq il-Ghamad - Light on bracket fixed against residence number 26, Mr. Charles Cassar now completely hidden by large tree which needs pruning.

**02. Triq is-Swieqi -**

- a. Plot near Golosa referred to several times in previous e-mails looks like a mizbla, particularly now that all greenery within is dried up exposing a variety of dumped rubbish. Enquiries essential re existing regulations concerning height of bordering walls. The same applies to the plot on the left past tunnel entrance which latter is the property of Government.
- b. Pavement bin closeby damaged
- c. Residence next to Marcel Coppini at 149 Tal-Barradi - hedges on pavement obstructing passage.

**03. Dog Signs -** Apart from installing additional bins, urgent replacement necessary of faded warning signs concerning dog 'shit' abuse.

**04. Triq is-Sidra (opposite Triq is-Sirk)-** Bus Stop painted road sign needs refreshing as partly covered following trenching work.

**05. Sqaq Lourdes Grotto area nr. St. Rita's chapel -** clearance of plot containing rubbish and other residue. Likewise, sweepers are not cleaning up on Sundays as stipulated within their contract.

**06. Traffic Rubber Calmers -** although many yellow blocks have been refreshed, those going down Triq il-Qasam towards valley as also that corner with Triq il-Gizimin are yet to be done.

**07. Triq Santa Katerina -** in the past, passage of traffic was prohibited in consequence to the presence of the fireworks factory. As this has been relocated further away from the road, we should enquire whether the position has changed enabling vehicles to enter Madliena through this vital road link.
