Subject: Minutes Council Meetings 23 October/13th November, 2014

Herewith details of those points raised by myself during the above two meetings for attachment as an appendix to the corresponding minutes:

01. Locality Directional Billboards – Mayor confirmed that relevant information still awaited from contractor.
02. Council Directional Signs in Triq il-Qasam c/w Il-Keffa/Il-Qantar/Il-Wizna – Exec. Sec advised that installation shortly
03. ETC additional seconded worker – Exec. Still awaiting information from Guido Zammit
04. Swieqi Entrance Tunnel sponsored embellishment – Mayor advised that interested party still awaiting relevant permits
05. Mica Med – Council agreed that absence of data requested as also delays in execution of repairs and submission of invoices justified delay in settlement of outstanding bills
06. Magazine – Deputy Mayor would be circulating all about deadline for submission of individual contributions since set for the 23rd November
07. Triq is-Swieqi Tiled Traffic Calmers – Council would write to Transport Malta for on-site inspection and approval should any modification in height be considered necessary.
08. Triq il-Qasam – Parking bay outside The Corner Store obstruction vision to motorists and appropriate measures to eliminate danger in the pipeline.
09. WiFi facility – Exec. Sec. obtaining quote for two to be located in the Civic Centre garden as also F.X. Ebejer in Triq is-Swieqi
10. Greenpack – Newly printed coloured leaflet paid for at the council's expense created some confusion in the collection times and although the company had submitted a draft for proofreading, this seems to have been overlooked.
11. Triq Fuq Il-Gonna – the light on bracket outside “Makik” apartments was concealed by overgrown shrubs/creepers and it was decided to shift this onto a pole.
12. Triq is-Swieqi – Installation of the new pedestrian crossing in the vicinity of the commercial outlets was scheduled to commence in mid-November
13. Tender for Household Garbage Collection – Exec. Sec. confirmed that this was in the process of being adjudicated
14. Financial Statements – approved but subject to clarification of the figure shown against Councillor's Allowances which reflected the incorrect figure inasmuch as this required adjustment in the payroll records to allow for amounts withheld for non attendance.
15. Triq is-Swieqi – road name painted just beneath tunnel entrance obsolete and an appropriate new sign required.
16. Council Diaries 2015 – when was distribution planned?
17. Triq is-Swieqi – agreed to shift two signs near the top corner off F.X. Ebejer garden and in the process remove some surplus signs within the garden which had been installed before entrances were limited from four to one.
