Sports day was slightly marred by the fact that the tennis court was not completed on time. For this reason we had to switch the event to Santa Clara. Admittedly a few children attended. However it was a start and I believe that this event has the potential to become popular.

Holy Mass – during the Mass, Rev Father Tony Agius thanked all the councillors for our hard work and dedication and he even asked the gathering for a round of applause! A very kind gesture indeed.

The acoustics night was a very pleasant and well attended.

The Family Art and Music Festival were also a success and so was the Music Festival. Both events were very well attended and those present seemed to enjoy themselves.

Sports Festival

Even the Sports festival was a success with a record number of participants. Over 320 people participated in the three categories.

Collection in aid of Dar tal Providenza

This year participants in the 5k run and 5k walk were asked to make a voluntary donation towards Dar tal Providenza. A total of € 1100 were collected and handed over to Fr Martin Micallef who was present throughout the activity.

Day Centre

I am pleased to inform you that it appears that things are moving in the right direction. The Department for Active Ageing is requesting less stringent requirements. During the inauguration of a Day Centre in Santa Lucia, the Parliamentary Secretary Hon Justine Caruana mentioned that there were plans to open a Day Centre in Swieqi.

Alterations to the toilets need to be made and the Parish Priest had to apply to the Curia for permission for the alterations to be carried out. We are now waiting for their go ahead.

Sub Committee for people with a disability

We are in the process to set up this sub Committee. Mr Mark Stephenon has very kindly accepted to help me set up this sub committee.

Till now Ms Bridget Micallef, Ms Roberta Magri and Mr Charles Palmier have accepted to participate.

Organ Donors Bank

We have been in contact with the Transplant Support Group and we plan to organise a drive for Organ Donation in Swieqi. As things stand the Support Group has very limited 'powers', since a relative may hinder the donation of organs, even though it would have been an individual's wish to donate his/her organs. However Parliament is meant to legislate on this matter before the end of the year and a campaign may be organised in the locality once the rules are changed.

The Transplant Support Group participated in Swieqi Fest on Saturday 5th September by setting up a stand.

Excavation works during the Summer Time

Works in Gejza and triq Ilqugh

As we know, trenching and similar works are not allowed in certain roads in Swieqi. We have had reports from residents of trenching works that were being carried in some of these roads with the blessing of MEPA. We protested with the authority about this, however it is evident that MEPA has not taken heed of our protest since this very afternoon works with a jack hammer were being carried out in Triq Ilqugh. The residents were very annoyed about this and they called me to protest that such works were allowed to be carried out. I am asking councillor Therese Valentino to once again protest with MEPA about this.

ID cards renewal

The process has come to an end. The feedback from residents was very positive and we thank the officials involved for the service given.

We did receive one strong complaint from a resident and this was forwarded to the authorities.

Transport Malta

On the 4th of September I sent 3 separate e mails to officials in Transport Malta, namely Mr Simon Grima, Perit Lorraine Bonnici Cassar and Perit David Vassallo wherein I asked for updates re access in triq it Terz, triq tal Franciz and triq il – Qasam/Gizimin.

To date I have not even received an acknowledgement, let alone a reply from all three officials.

Now that the budget for Basis year 2016 is being finalised, I have once again written to Transport Malta CEO, Mr James Piscopo, to the Hon Minister Joe Mizzi and to the Hon Prime Minister asking them to provide the local council with sufficient funds to repair Triq il Keffa.

I have stressed that this road is a top priority and that it is in a terrible state.

28th August – meeting with the police traffic section

A very informative meeting was held with Inspectors Sergio Pisani and Pierguido Saliba who explained in great detail matters and replied to our queries relating to traffic, ranging from clamping and towing to obstructions, vehicles bearing foreign registrations, parking of commercial vehicles etc.

I suggest that we invite these gentlemen to give a talk to residents on traffic management

2nd September – Bonnici Bros Ltd

An official from Bonnici Bros gave us a presentation of a new product being introduced on the Island for the repair of roads. This material can even be applied in wet weather. A demonstration how to apply the product and its durability will be given to our contractor and handyman.

4th September – meeting with MEPA.

A meeting was held on with MEPA and various themes were discussed. Minutes of this meeting which were prepared by Mrs Valentino are attached.

Points raised at Local Council meeting of 10th September 2015

1. Triq l-Gharbiel between Triq id-Dris and Triq is-Sirk is two way but is one way further down. This is dangerous because this part of the road is too narrow, and in any case, the end further down is one way. Would Council consider having it one way please?
2. Triq il-Uqija in front of houses called Rowlyn, Shamrock and Luna, there is enough space for a car, yet it is allocated to motor cycle space with double yellow lines on either side. Would car space be allocated instead please?
3. Meeting held on 4th Sept between MEPA and SLC (Mayor Noel Muscat, Councillor Theresa Valentino, Perit E Rossignaud and Perit Anton Valentino). Attached are minutes of meeting.
4. Wardens. What is situation in Swieqi at the moment? How many wardens operate? How much time are they in Swieqi for? At what time are they here? How much are they paid and who pays them?
5. Valley road connecting San Gwann to Swieqi. Have Transport Malta done Traffic Impact Assessment and advised Swieqi of how it is going to be affected by traffic diversion when Kappara flyover is being built. Residents have right to know. I am still concerned about necessity of a pavement. Would SLC work with San Gwann Council and write to Transport Malta about this issue together.
6. Street lighting. Mark Stephenson continues to follow up works being done and co-ordinate between SLC and Enemalta. On 6th August, meeting between Mr Alfred Curmi , Mark Stephenson and myself was held. I asked for costs involved in the maintenance, setting up and other works related to Street Lighting. Mr Curmi gave the figures as follows: Year 2013: 31467

euros. Year 2014: Total Swieqi: 54035 euros of which 29159 euros related to works excluding Madliena and 24876.35 euros were allocated to Madliena area alone. (new works near Madliena Fort cost 18958 euros). Since there has been a delay in the signing of the Contract for Regjun Tramunntana, the SLC has extended contract with MICAMED to end of Dec 2015. PROPOSAL: Since in a number of instances, lights do not always work after Works Order is carried out, can we ask contractor for some form of confirmation that they declare that lights are working to their satisfaction together with the invoice presented.

7. Railing (poggaman) along stairs leading to Community Hall: Can we have railings placed along stairs leading down to Community Hall. They were sorely missed by residents who went to apply for ID Cards.
