
Applikazzjoni fuq il-Cow Farm f'Wied Ghomor

Il-Perit Anton Valentino informa l-Kunsill li daħlet applikazzjoni l-Awtorita ta' l-Ippjanar sabiex it-tlett blokki li kienu jservu ta' Cow Farm f'Wied Ghomor jitwaqqaw u minflokhom jitilgħu tlett blokki, bl-istess area u għoli izda jsiru ufficini. Din l-applikazzjoni għal xi raġuni jew oħra saret taħt il-Lokalita ta' San Gwann.

Il-Perit informa li pprepara l-oġġezzjoni għal din l-applikazzjoni fejn l-ewwel punt li rrefera għalih hu li din hija applikazzjoni fuq art ODZ, l-linji gwida mill- Awtorita ta' l-Izvilupp huma li f'dawn iċ-ċirkustanzi jiġu kkunsidrati applikazzjonijiet għal proġetti ta' biedja, agrikoltura u ortikultura, agri turizmu imma zgur mhux ufficini. 

Points to be raised at SLC meeting on Thursday 16th August 2018

As we all know, development in Swieqi is going on at a very fast rate. Would the Executive Secretary ask the Government Department responsible for drains:

1. for a copy of sewage system plans existing in Swieqi
2. to state what the maximum capacity in terms of number of households/businesses can be accommodated by the present system
3. to state whether a study has been carried out to gauge the ability of the present sewage system to cope with the increased population generated as a result of the increased density brought about by the Planning Authority's DC 15 Document.
4. to inform the Council of any plans to upgrade the system as a result of point 3 above.

This information is required by the Council in order to better plan for road works and surfacing in our district.

Traffic wanting to reach Triq Pedidalwett from St Andrews Road. With the problems that arise when traffic from St Andrews Road turns into Triq is-Slielem where vehicles are exiting Greens Supermarket, I propose that traffic goes to the next turning, Triq il-Perkursur and then turns into Triq is-Slielem from there and up Pedidalwett, thus avoiding dangerous situation with a very simple solution. I propose councillors to try that route and see for themselves what a simple solution it is. If agreed, let's action it.

Funds for Triq il-Pedidalwett and Madliena Hill. Since I have been pushing for works at Triq il-Pedidalwett to be completed, the Executive Secretary, after a lot of ground work has managed to locate the funds allocated to this project. I am delighted that we can now go forward with this very badly needed project at the bottom end of Triq Pedidalwett.

In reference to the attached document, herewith my comments and those points which require clarification and/or correction. As usual, this e-mail to be attached as an appendix to the corresponding minutes of the local council meeting of the 16th August:

04. K. Cardona (225.00) - description to read: in replacement of cheque No. 9476 (I could not reconcile this particular cheque number in my records and as was the case with that of Central Garage?) See Clarissa's explanation above

07. ARMS (444.64) - relates to the tennis court. Incidentally, have we received up-dated Income & Expenditure data from those administering the tennis court concession as it is quite some time since such information was made available to us? Agreed, will ask Justin at Council Today

11. Mazars Consulting (495.60) – presumably this will be the final fees invoice and how do we stand with the preparation of the Financial Statement for the 2nd Quarter of this year.

Perhaps we still need to issue another cheque, as we still need handing over to new accountant. I will be meeting Mazars and the new Accountant as soon as the appeals period elapse.

15. Central Garage (118.00) - does this represent an increased garaging charge for the newly acquired vehicle, which is double when compared with previous arrangements? The increase (including VAT) was agreed at council. The Garage we currently use has been requested back from Central Garage, but this was a problem for us, as we needed it. We were offered another garage, smaller, with no electricity and with humidity which I did not accept, but I had a one-to-one with Central Garage and had agreed to keep the same garage but with an increased rent.

20. H. Zammit (362.50) – part of consultation fees relate to the preparation of the Business Plan (in new format) which I understand should fall within the remit of our accountant in consultation of course with you, the Mayor and whoever; could I have a sample copy of this document for my records. As I discussed with you personally, the business plan today is different from the business plan that Hugh used to prepare – they now require specific information related to depreciation and accruals that only an accountant can prepare, this is not within my capability, and I can only assume neither is it within Hugh's either. So I discussed with Ramon and with other Executive Secretaries in other councils and was clearly told that it is the Accountant who should be doing this and not us Secretaries. So this is the first issue I need to discuss with the new Accountant, as Ramon made it very clear way back that he will not be doing it.

26. Derek Garden Centre (1,259.68) – Am I right in saying that the total cost of the planters is being reimbursed by the sponsors? Which sponsors Alfred?

On a general note, a further gentle reminder about the following:

- a. Schedule of Payments No. 43 d/08.05.18 to 01.06.18 - (H. Zammit (625.00 item no. 10) info requested still awaited your e-mail dated 4th June refers)
- b. Schedule of Payments No. 47 d/02.06.18 to 28.06.18 – ARMS await confirmation that Maltapost have their own meters; my e-mail dated 4th July refers.
- c. Galea Cleaning Solutions – organic bags Monday collection reimbursements. When this matter was last discussed with you, I was told that a new agreement was in the process of being entered into.

In the absence of any objections other than those raised, approval of payments is recommended.
