Garbage / waste separation – enforcement

During January 2016, Swieqi introduced Organic waste separation. We are proud to have undertaken this big challenge since we want to help to improve the environment. The system is working very well in the residential zones. However we are facing stiff challenges wherever there are short let flats.

We had offered solutions to the Hon Minister of Tourism and we have regularly cried for the authorities to enforce. Unfortunately we have never been given any help and this is making us very nervous.

Identity – Regional Art & Culture Centre

To date Swieqi does not have an identity of its own. The rapid increase in the population and the large amount of foreigners that are living in the locality call for an urgent intervention to save the locality from becoming an anonymous locality, without any sense of identity.

It is the Local Council's express desire to associate the locality's identity to Culture & the Arts. For this reason we wish that a Regional Art & Culture Centre be set up in the locality, where all forms of art are thought and exhibited.

Accessibility

Accessibility in the locality is very poor. One of the main entries in the locality is through a narrow bridge that was built in the sixties to serve horse drawn carts when what is now Triq is Swieqi was still a valley. People, accompanied by their children and pets have to walk alongside cars. An absolute inconvenience and a daily risk.

Moreover, certain roads are still not fully accessible since they are dead end. There is an urgent need that these roads be made fully accessible so as to improve the traffic will flow more and help to decrease the overload of traffic and danger in certain roads.

Roads

Some roads are in a pitiful state and the local council cannot afford to even attempt to resurface them. We have been asking central government for financial assistance but to no avail. Triq il Keffa, triq it Tiben and triq il Giebja must be rebuilt at a cost of circa €M 1.2 . Other roads need major repairs.

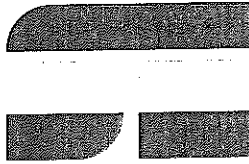
