





Council meeting 23.11.17

Meetings held

27.10.17 - J Portelli Projects Ltd

I met up with the project manager of the Forum Project, Mr Justin Caruana, so as to discuss the costings for the embellishment of Pjazza Uqija which totalled € 150,000. In our opinion this estimate is too high and the project Manager did admit that a couple of items may be overstated, however do date he has not presented a revised version.

I am under the impression that J Portelli Projects are not keen to carry out the job and they prefer to give us the promised € 50,000 and we will handle the project ourselves.

I have settled for the latter option and have asked the Executive Secretary to issue the tender for these works. According to the Executive secretary we do not need to issue a tender for these works since he was advised that the works may be carried out by the contractor who will be awarded the contract for major patching. I am not convinced since the contractor who may be awardee the tender may not be sufficiently equipped to carry out these works. I would feel much better if the tender were issued. Thus we could compare prices, quality etc.

27.10.17 - Commissioner of Police

Together with Vice Mayor Dr Justin Fenech, the Executive Secretary and a delegation from the Malta Tourism Authority we met the Commissioner of Police together with two Assistant Commissioners.

During the meeting we discussed the situation regarding the pilot project of the cameras that were installed in the locality by the Malta Tourism Authority and are being maintained by the Local Council. To date the recording equipment is housed at the local council premises and this is causing extra work on the executive secretary and unnecessary delays in delivery of the films in that whenever people request a download of a recording they must first call the police and the police in turn order the local council to download the film. This causes unnecessary delays in the delivery of the film in that the council is closed after office hours and during week ends and public holidays, thus losing a great deal of precious investigative time. It was agreed that the police will instal the recording equipment in the police station too.

During the same meeting we asked the Commissioner whether the service at the Swieqi Police Station could be improved by keeping the police station open at all times. He promised us that once the new recruits will take office, some of these will be deployed to the Swieqi police station.

07.11.17 – MTA

Together with the executive secretary we met the new CEO at the Malta Tourism Authority, Mr Ronnie Vella who was accompanied by Mr Mark Scerri Simiana.

During a very cordial meeting we discussed the possible assistance that could be given by the Authority to the locality and it was agreed that that the Authority would finance part of the cost of the embellishment of Pjazza Uqija. The amount which will be forwarded must still be decided.

It was also confirmed that the Authority will be forwarding €7,000 to finance the purchase of new bins. I am eagerly waiting for the Executive secretary to conclude the purchase of these bins.

08.11.17 – Urgent Council Meeting

An urgent extraordinary meeting was called so as to allow the architect of Bonello Service Station to briefly demonstrate the proposed project that is being planned in the property of the petrol station which is still in the phase of outline planning.

It was concluded that the Council informs the Planning Authority that it be kept informed of all the discussions and developments that will be taking place with regards to this project. The local council is not against and development as long as this does not effect residents in the vicinity or even the locality in general negatively

13.11.17 – Neighbourhood Watch

A meeting for residents was organised by the Madliena Administrative Committee together with the Victim Support Group so as to explore the possibility of setting up a neighbourhood watch in Madliena on an experimental basis, by making use of modern technology such as WhatsApp, Messenger and FaceBook besides others. Also in attendance where Assistant Commissioners Martin Sammut and Alexandra Mamo who took a active part in the discussion. Councillors MaryAnne Abela and Theresa Valentino will report in greater detail about the outcome

14.11.17 – President of Malta

Together with Councillors Theresa Valentino, Paul Fenech and Matthew Bonello we met Her Excellency The President of Malta. We renewed the plea that we had made to her during our first meeting on 3rd May, for her assistance so as to help us have more open spaces in the locality and for the setting up of a regional Art and Culture Centre in the locality. She promised that we she would organise meetings with the parties involved.

During the same meeting we presented Her Excellency with a painting of Wied Ghomor ably painted by councillor Paul Fenech

16.11.17 – PA appeal re Hostel

Together with Perit Anton Valentino I attended a hearing during which the owners of the block of building in the corner of triq il Qasam/Triq l-Imghazel has presented new plans so as to turn the whole building into a commercial building. One of the proposals is the operation of a hostel. Yes, once again a hostel is being proposed. I made my submission to the board and informed them that the local council and the community are dead against the setting up of hostels in the locality. It transpired that the developers did not have an MTA licence as yet and a technical debate ensued between our architect Anton Valentino and the developer's architect. The decision has been postponed to early January.
